This will replace the 2007 Wellness Policy. Motion Passed 6-0 on a roll call vote. Noel moved and Miller seconded a motion to approve the use of local substitutes. Motion passed 6-0 on a roll call vote.

Discussion Items: Administrative report: Mr. Ippensen reported attendance at the Blue River Cohort meeting. He shared the teacher's summer progress reports. ACT test scores were reviewed.
