District Rating

Shickley Public Schools was one of 32 school districts recognized by the state as an "Excellent" school. The accountability system utilized by the Nebraska Department of Education, AQuESTT, recognizes school districts as either: needs improvement, good, great, or excellent. There are 244 total school districts in Nebraska.



MAP Growth: Measure of Academic Progress

MAP Growth measures what students know and informs what they are ready to learn next. MAP Growth is a personalized online assessment que that provides immediate feedback to students and staff. Reports generated by NWEA helps the teachers teach, student learn, and administration lead.

Percentile ranks indicate how well students perform in comparison to the specific norm group; by grade and subject. Each percentile rank indicates that the student score as well or better than the percent of students in the norm group. For example, a student scoring in the 85th percentile scored as well, or better than, 85% of all students in his norm group nationally. It also means that only 15% in the norm group exceeded the score.

Below you will see the percentage of 2018-2019 students by each grade and subject 2nd-10th that scored in the average, high average, and high when compared to same age and area national norms:

Did you Know?


- 62.5% of our teachers have a Master's Degree (55.99% is the state average)!
- Our pool provided 45 children swim lessons and employed 14 high school and college-aged students!
- In 2019, our daycare brought in \$102,681.50 in revenue serving 67 children for 44 families!
- Our school provided Drivers Education to six students at no cost to them or their families!
- SPS pays full tuition costs for our students enrolled in SENCAP courses! (The SouthEast Nebraska Career Academy Partnership offers academies in Agriculture, Business, Construction, Criminal Justice, Education, Health Services, Information Technology, and Manufacturing in Energy and Welding.)
- SPS pays full tuition costs for High Ability Learner students enrolled in dual credit courses!
- On average our three and four-year-old Preschool program has served 16 students each year, and for the next 2 years that number is projected to be 20 students!

Financial Information


Being fiscally responsible to our patrons is something Shickley Public Schools takes very seriously. Just shy of 70% of our total expenditures went directly back into student instruction. As a rural Nebraska school, you can see we depend heavily on our local receipts in order to continue to make a positive impact on our students and community. A combination of lowered tax valuations and our district long-range, strategic planning process, resulted in an increased of \$121,221.582 tax asking above the average of the past four years: \$3,199,303.42.
